Pursuant to section 14 Registration of Business Names Act 1963, the Minister for Business, Enterprise and Innovation has the power to refuse to permit the registration of any name which in his/her opinion is undesirable.
- (2) Nature of business.
- (3) Principal place of business.
- (4) Other name(s) under which the business is conducted.
- (5) Corporate name of the body corporate
- (6) Registered office, in the state, of the body corporate.
