#### note one

A new application can only be granted where the form T1 is accompanied by a supporting statement issued from an officer of the Garda Síochána not below the rank of Chief Superintendent. The exemption can only be made in respect of notifications of new addresses. It is not possible to remove any residential addresses that are placed on the public record.

#### note two

Where Form T1 is accompanying an application for appointment, please state which submission the form T1 is related to.

## For example:

Form A1, application to incorporate an Irish company
Form B10, appointment of director/secretary
Form B10a, notice of change in director's name/address - multiple companies
Q1 form, application to register migrating company by means of continuation
SE Form, Societas Europaea form
