1. INTRODUCTION

The CRO Mission Statement is to:

ensure a high level of filing of returns due, a rapid turnaround of the information on those returns with the assurance that the information provided to us complies with the relevant statutory provisions and that the information supplied by us accurately reflects that provided.

We divide that statement into its three parts covering INPUT, getting companies to file returns due, OUTPUT, ensuring that the public have ready access to those documents and QUALITY, endeavouring as far as possible that the documents are properly completed and that we furnish correct information in turn.

We made good progress under all three headings.

Our high level target of having companies up-to-date in filing annual returns was exceeded. We are finding however that as we exceed 90% of companies up-to-date it is becoming increasingly difficult to make further advances.

Our receipt and scanning of documents for online access are working well and very few searches are now done manually. Through the European Business Register Irish company records can be inspected through company registry websites in most of Europe.

The quality of documents filed is greatly enhanced by electronic filing. The up-take of electronic filing options in 2008 was very encouraging.

While it is a major priority for the office to have returns filed on time we are anxious to achieve that while not imposing an excessive administrative burden. According to figures independently prepared for the High Level Group on Business Regulation, customers of the CRO saved over €20 million during the year in the preparation of returns using one of our electronic filing options. In addition to savings in the completion of returns, those that filed electronically saved a further €3.5m in filing fees as electronic filing either carries a lower fee or is free.

In 2008, according to the World Bank report "Doing Business 2009", Ireland ranks 5th in the world (and first in Europe) in the low cost of starting up a business. The cost calculations are based on the administrative processes involved and the time for the completion of those processes. That is the same ranking as in the 2008 report.

2. INPUT

Enforcement/Compliance

Enforcement actions

We had flagged enforcement action against delinquent companies as an enforcement priority for 2008. By end-year, 27 companies and their directors had been taken to the High Court and costs

amounting to €24,000 had been awarded.

As regards prosecution of overdue companies, 97 companies were convicted in the District Court in 2008. The total fines imposed were €117,100 and total costs awarded came to €14,500.

In line with our commitment to maintain the strike-off of overdue companies, we struck off 5,804 companies on an involuntary basis, 4542 companies on a voluntary basis and we struck off 223 companies for failing to file specific documents with the Revenue Commissioners.

Late Filing Penalties

From the commencement of late filing penalties in 2001, CRO has been anticipating a serious fall off in receipts from that source as we were expecting the stricter enforcement regime to result in more companies filing on time. The late filing penalties peaked in 2003 at almost €28m before falling back to €18m in 2004.

In 2008, a small reduction to €17.67m was achieved but this is still far short of what would be acceptable. Despite a rigorous enforcement campaign, which has resulted in 90% of companies being up to date with their filing at year-end, the percentage of annual returns that are filed late continues to be quite significant at approximately 16.8% in 2008.

Other activities

We worked closely with the Office of the Director of Corporate Enforcement, in respect of the disqualifications of directors of dissolved insolvent companies.

Results

The key measure of the effectiveness of our work in securing compliance by companies with their statutory filing requirements is the number of companies up-to-date at any given time. The figure at 31 December is the figure which counts for annual report purposes and at 31 December 2008, that figure was just over 90%. We had set 89.5% as our target. The comparable outcome one year earlier was 88.5%.

Liquidations and Receiverships

The number of insolvencies increased in 2008, but we nonetheless achieved our targets for processing and scanning the resulting documents. Reports of companies in liquidation continued to issue to the ODCE on a weekly basis.

3. OUTPUT

New Companies

The three company incorporation schemes, as outlined below, were consistently within the committed time frames during 2008.

Fe Phráinn – 10 working days CRODisk – 5 working days Ordinary Scheme –15 working days;

We normally incorporate companies on the CRODisk system within two working days. Reregistrations and Change of Name applications were consistently processed within 10 working days during 2008.

Business Names

A substantial backlog in registrations had arisen by the autumn of 2008. We transferred staff from other sections of the Office and the backlog had reduced considerably by end-year.

Mortgages

In 2008 we continued to achieve our targets of scanning mortgage documents within 7 days of receipt. The Slavenburg list was maintained up to date for public viewing and the registration of satisfactions was also kept up to date. It was not always possible to achieve our target of registering mortgages within the 14 day limit set out in the Business Plan but processes are continually being reviewed to address this issue.

Limited Partnerships and External companies

We achieved our targets for the processing and scanning of all Limited Partnerships and External companies documents within 7 days of receipt. The exercise of updating the register of external companies, by contacting each branch that is in arrears with filing, is ongoing. Work also began in 2008 on reviewing forms in relation to both Limited Partnerships and External companies.

Post-Incorporation

The targets for receipt and scanning documents were exceeded over most of the year, There was a very large backlog of B10 registrations in the March/April 2008 period due to due in large part to carry-over from the move to Carlow and the October/November 2007 peak. Processes and timescales were closely monitored during and after the October/November 2008 peak, and were kept within targets.

Postal Lodgements and Annual Returns Section, Carlow

Since July 2007, 32 CRO staff have been located at O'Brien Road, Carlow, as part of the first phase

of the decentralisation of the CRO to Carlow. The primary function of the office in Carlow is to act as a postal lodgements office and annual return processing section for the CRO.

The following documents, and accompanying fees, are processed to "received" status (including scanning) in Carlow:

- annual returns and correspondence regarding annual returns,
- submissions relating to:
 - directors, secretaries, registered office address, auditors
 - liquidations, receivership, wind-up
 - amendments to share capital,
 - amendments to memoranda and articles of associations
 - restorations
 - resolutions
 - changes to membership
 - prospectuses
- applications to open customer accounts and cheques for lodgment to customer accounts.

Processing times and Customer Service

For 2008, the Carlow office undertook (a) to "receive" all documents on the computer (and hence have them appear as received on the online service) within three days of receipt at normal times and within five days at peak times of the year and (b) to prep and scan within a further 24 hours of being "received" normally and three days at peak. These targets were generally achieved and often exceeded during the year. Every effort is made to ensure that phone queries are answered immediately and emails within 24 hours.

Annual returns

The CRO received a total of 178,000 annual returns in 2008 of which 77% were received in Carlow and 42% were received electronically. The processing of annual returns to receive stage is the core business of the Carlow office. Very high standards were achieved in that work in 2008, even though most of the staff had been newly recruited to the CRO in 2007. Considerable progress was made in relation to both quality, in terms of consistency and thoroughness of checking, and quantity in terms of processing of high volumes and prompt turnaround times.

Seasonal peaks

Major backlogs that had arisen in earlier years during seasonal peaks were not allowed to accumulate in 2008 as processes and timescales were closely monitored especially over the October peak. 50,000 submissions were received and processed through the cash system during the month of October 2008 alone. Over 33,000 of these were annual returns of which over 16,000 (48%) were electronic. These volumes were dealt with in record time in 2008 and processing was up-to-date by early November. This was achieved mainly due to the ongoing co-operation, commitment and expertise of CRO's clerical staff in both the Dublin and Carlow offices.

Electronic Filing

The CRO implemented a number of initiatives during 2008 to encourage and support companies wishing to file documents electronically, including the provision of an e-filing helpline in Carlow. The helpline was manned up to midnight on 28 October, the last day of the peak filing period. By January 2009, the percentage of annual returns filed electronically had risen to 53%.

Registration of e-filed annual returns:

The aim is to extend the use of the pre-filled annual return as a means of reducing and eliminating the backlog of unregistered but received and scanned annual returns.

More than half of the 446,861 submissions registered in 2008 were auto-registered as a result of the electronic filing of submissions combined with a rules engine which has increased the quality of submissions and the data entry project which converts manually filed documents to electronic format. For the first time in many years, the number of annual returns registered in 2008 (219,000) exceeded the number of annual returns received in the year (178,000), a trend which if continued would in time result in the clearance of most of the backlog of unregistered annual returns.

Request for waivers of late penalties:

Decisions on appeals against imposition of late filing fees or related issues were generally transmitted within 2 weeks of receipt. In 2008, almost 800 requests for waiver of late filing penalties were processed of which about 58% were granted. The value of the late penalties waived totaled €427,000.

Filing & Storage:

It was intended that following decentralisation, all CRO documents would be sent to Carlow for storage and that Carlow would become the central repository for all CRO documents, both current and historical. Due initially to difficulties in sourcing a suitable off-site storage facility in Carlow and then the budgetary situation, this did not proceed in 2008. However, it is expected that an off-site facility to store current documents in Carlow will be operational in early 2009.

Dishonoured cheques

A project to recover a backlog of dishonoured cheques was completed towards the end of 2008, having achieved an acceptable degree of success. In order to deal with the ongoing problem of dishonoured cheques, the following more stringent measures were introduced in 2008:

- Presenters who have failed to replace a dishonoured cheque in the past: CRO will no longer accept cheques from these presenters. Until such time as the outstanding debt to CRO is paid, payment from these presenters must be made by cash, money/postal order or bank draft.
- Current submissions: Where a cheque used to pay for a current submission is dishonoured, CRO will reject the submission for registration unless the cheque is replaced by cash, money/ postal order or bank draft within 14 days.

Backfile Project

In preparation for the full decentralisation to Carlow we embarked on a project, in 2006, to scan all of the pre-1990 documents for live companies, which had not been scanned. All of these have been scanned and indexed, over 70% of which have been transferred to the imaging system and are now available online for public inspection. The remainder will be transferred during the first quarter of 2009.

Bulk Data

We achieved our objective of delivering data products to CRO customers in accordance with published delivery commitments. The image upload facility was successfully upgraded in the first half of 2008.

Web Search facility

We set a target for 2008 of 95% of searches carried out on line. This target was exceeded with 95.17% of searches conducted online in 2008.

System Downtime

Our commitment was to ensure a rapid response to unplanned downtime.

Unplanned System downtime was minimal during the year.

IT Security

During 2008 our IT network infrastructure was re-designed to increase security and robustness. This delayed other planned projects because of the considerable work involved and the fact that other tasks could not be commenced while it was ongoing.

Disaster Recovery

We undertook to have a trial run during 2008 of a complete transfer of IT systems to a replica system off-site. The feasibility of this is currently being questioned and the disaster recovery plan is being reviewed.

System Development Partners

The contract with our system development partners expired in April 2008. A tender process commenced in December 2007 and the new contract was agreed with the successful bidders by the expiry date.

4. QUALITY

Business Process Re-engineering (BPR)

During 2008 an external consultant was engaged to review the revised processes, which had been put in place following the decentralisation. The report, which was received in early 2009, is currently being considered.

Rules Database - Auto-registration

To facilitate transparency and to improve quality we published some time ago a set of rules that govern the processing of returns. This has been integrated with the vast majority of the various submission processing systems. This facility is beneficial for training of new staff. In addition, the frontloading of a rules engine on the e-filed annual return application has resulted in an increase in the quality of the forms being filed.

The rules engine combined with the electronic filing of submissions enables auto-registration, i.e. if the engine can determine that all of the rules have been passed then the submission can be registered without any manual intervention. Of the 446,861 submissions registered in 2008, 239,133, more than half, were auto-registered. In 2008 we commenced work on extending the frontloading to the other online forms with the objective of increasing the rate of auto-registration and thereby freeing up resources.

XBRL

In July 2008 the High Level Group on Business regulation concluded:

"In summary, the Group believes that by introducing a simultaneous return date to CRO and Revenue, by phasing in mandatory e-filing, including accounting data in XBRL-format, and by ensuring that agencies can cross-access data, the burden on business will be considerably reduced".

Consequently, CRO, with the aid of external XBRL expertise, conducted a study to test the feasibility: "that within five years XBRL reporting will be mandatory (for certain size companies at least) and CRO commits to receiving and processing some XBRL encoded company accounts (Accounts) from Public Limited Companies (PLCs) next year as a Pilot Service."

The conclusion was that it is technically feasible to accept accounts electronically subject to business considerations. The development of a pilot service to accept financial statements in XBRL has commenced.

Savings from e-Initiatives

In April 2008 analysis on the value of e-government projects was conducted which showed the following:

Because of the increased enforcement of, and compliance with, the requirement to file annual returns,

and the general increase in business activity in Ireland, the number of submissions received in the CRO had increased, at the end of 2007, by 42% since the year 2001 without any increase in staff numbers.

In accordance with the costing model used by the CRO, salaries including overheads in 2007 amounted to €7.13 million.

The fact that we have been able to deal with a 42% increase in workload without staff increases represents a staff cost saving therefore of €2.99 million. This was only possible because of developments in computer systems, in particular, e-initiatives.

The savings from electronic filing for the CRO arise as follows:

- reduction of data entry data to update the register is entered by the customer and does not require re-keying,
- reduction in scanning of paper,
- reduction in numbers sent back for correction due to improved quality of forms filed as a result of upfront validation of the content and
- reduction in checking content content of forms can be programmatically checked for inconsistencies
- elimination of any manual intervention for online company searches.

There have been even greater efficiencies for the citizen.

In monetary terms, the fees for electronic filing versus paper have been adjusted to take account of the reduced cost of administering electronically filed documents. In 2008, the citizen saved over €3.5m in filing fees by filing electronically. 84% of the forms filed could have been filed electronically giving a potential saving of €6m.

The web-based annual return filing application presents to the filer a pre-filled annual return, which they only have to check, amend where appropriate and sign. In the Report of the Business Regulation Forum of March 2007 a pre-filled annual return was highlighted as a major saving to companies. The administrative cost of completing the annual return was given in that report as €247 per return or €35.85 million for all companies.

Savings arise as follows:

- A much reduced time for the completion of the return.
- An increased likelihood that the return can be completed without expensive expert support.

The High Level Group on Business Regulation in its report of July 2008, commenting on the CORE pre-filed annual return facility, stated

"Adjusting this cost to reflect the time saving through e-filing, and the percentage of companies doing so (17%), the High-level Group estimates that the overall cost is reduced from €35.85 million to €25.4 million, a saving of over €10 million.

As 2007 was the first full year when CORE was available for annual returns, it is likely that the time (and cost) associated with this route will fall as companies become familiar with it. Secretarial software packages have been in use for a number of years.

Moving to a fully electronic environment would yield further savings, and a saving in total administrative costs of around €28 million is possible." The percentage of companies filing their annual return through CORE has since increased to 31%.

Use of ROS Electronic Signature

In 2008, it was agreed that Revenue would provide CRO with access to the ROS electronic signature for the signing of forms filed under the Companies Acts. Some software development will be required.

Take-up of e-Filing

During 2008 the take-up of e-filing continued to increase. The following shows the increase since 2004:

In January 2009, 52.7% of annual returns were filed electronically. In 2008, 176,000 submissions were filed electronically, a 40% increase over the previous year.

Company Name Reservation

An application to allow reservation of a company name has been developed and tested. Changes to legislation are in train, which will allow it to be implemented.

Strategy to Encourage Take-up of e-Filing

Due to budgetary constraints our plans regarding this strategy had to be abandoned. However, we will proceed on a much less ambitious basis using internal resources.

5. CUSTOMER SERVICE

CORE (Companies Online Registration Environment)

CORE allows presenters to view, in a managed environment, up to date information on companies for which they are a filing agent. It also allows customers to view their accounts' statements and transactions. It's popularity remains consistent, receiving some 11,000 unique visitors per month.

e-Reminders

In 2008 it was decided to provide a facility to allow companies to opt to have their ARD notices/ reminders e-mailed to the company and other elected e-mail addresses. This will enable notices to go the company filing agents as well as the company. Work has commenced on its development.

Information Unit

The Information Unit provides a front line service to customers who contact the Office by telephone, fax, post and e-mail. It also organises the CRO's participation at exhibitions, seminars and open days. The benefit for the customer is that it allows first call resolution to the query and eliminates the frustration of being transferred. This service relieves each section within the CRO of the burden of answering unrelated calls thus having less interruptive work patterns.

The CRO received over 150,000 phone calls during 2008, an average of nearly 2,900 calls a week. It is expected that the number of calls received during 2009 will remain at around the same level.

An e-mail handling system is available to give customers alternative methods of contacting the office (info@cro.ie).

Over 13,000 e-mails were answered during 2008 with the majority of emails answered within eight hours of receipt.

In 2008 we automated the generation of Letters of Status enabling a much faster turnaround for these requests.

Publications

The CRO published an ezine monthly during 2008. This is an electronic bulletin that informs subscribers of the current developments within the Office and also notifies subscribers of future events.

In Spring 2008 an information bulletin issued to all company directors. This edition dealt with Health & Safety in Workplace, CSO developments, ODCE review and the move towards electronic filing.

An advertising campaign was conducted to remind customers of the consequence of filing late in terms of the loss of entitlement to audit exemption.

A request for tenders for the upgrade of cro website and content management system was published and the winner bidder selected. The redevelopment is currently underway.

Customer Present Credit Card Facility

A preferred provider of customer present credit card payment facilities was selected during 2008. While this service would be welcomed by our customer, the cost benefit from CRO's point of view will have to be re-evaluated in light of budgetary constraints and the likely reduction in customer present transactions as a result of the decentralisation of the public office to Carlow in 2011.

6. DECENTRALISATION ISSUES

The physical separation resulting from the decentralisation of part of the CRO to Carlow has resulted in the need for continuous liaison between the sections based in the two offices. The continued efficient operation of the Office, despite the physical separation, has been achieved through the goodwill of staff and ongoing co-operation and discussion which has been facilitated by the installation of video-conferencing facilities.

Main Decentralisation to Carlow:

Planning permission for the main decentalisation building was granted by An Bord Pleanála in November 2008. There were a number of conditions attached to the decision which required OPW to submit revised plans. This was done in early 2009 and construction is scheduled to commence in late April 2009. The construction period is 18 months which would give a completion date of Q4 2010.

Restoration of Companies to the Register

Section 311(8) and section 311A of the Companies Act, 1963, and section 12B.(3) and section 12C of the Companies (Amendment) Act, 1982 provide for the restoration of a dissolved company to the Register of companies. A company may be restored to the Register by application to the:

- High Court before twenty years have elapsed from the date of dissolution;
- Circuit Court before twenty years have elapsed from the date of dissolution, where the applicant is a creditor;
- Registrar of Companies before twelve months have elapsed from the date of dissolution, where the application is made by or on behalf of the company.




