Common Draft Terms of Merger (the Common Draft Terms), which is set forth in the Annex to the said Originating Notice of Motion.

- That the Court make an order pursuant to Regulation 14 of the Irish Regulations, confirming scrutiny of the legality of the Proposed Merger as regards that part of the procedure which concerns the completion of the Proposed Merger, so that Tendercapital and the SICAV may merge upon the terms of the Common Draft Terms and Tendercapital shall be the "Successor Company" as defined in the Irish Regulations.
- Further or other relief.

Whereupon and on reading the said Originating Notice of Motion, the Affidavit of Raymond O'Neill sworn on the 17<sup>th</sup> day of November 2021 and the Supplementary Affidavit of Raymond O'Neill sworn on the 24<sup>th</sup> day of November 2021 and the Affidavit of Christian Currivan sworn on the 30<sup>th</sup> day of November 2021 and the Supplementary Affidavit of Christian Currivan sworn on the 17<sup>th</sup> day of December 2021 and the documents and exhibits referred to in the said Affidavits, inter alia confirming the Applicants' compliance with the directions of this Court to advertise the hearing of the Originating Notice of Motion,

And there being no appearance by or on behalf of any party other than the Applicants,

And on hearing Counsel for the Applicants

THE COURT ADJOURNED the matter to 2pm on Thursday the  $23^{rd}$  day of December 2021

And, on the said adjourned date, upon reading the Affidavit of Tom

Casey sworn on the 23<sup>rd</sup> day of December 2021 to which was exhibited the

certificate from the Luxembourg competent authority confirming that the SICAV

has completed the pre-merger requirements under Luxembourg law,

And on further hearing counsel for Tendercapital with regard to that company's application for a certificate pursuant to Regulation 13 of the Irish Regulations,

THE COURT DOTH CERTIFY that Tendercapital, as the successor company for the purpose of the proposed cross-border merger, has completed properly the pre-merger requirements of the Irish Regulations within the meaning of Regulation 13 thereof in respect of a proposed merger with the SICAV, and HEREBY DIRECTS that a pre-merger certificate in the form prescribed by Order 75 Rule 21 of the Superior Court Rules issue to the Applicant as confirmation of such.

And on further hearing Counsel for the Applicants in respect of their joint application for an order pursuant to Regulation 14 of the Irish Regulations

And no other person appearing on behalf of any creditor or member of, or other interested party in, Tendercapital or the SICAV.

IT IS ORDERED AND CONFIRMED that pursuant to Regulation

14 of the Irish Regulations, the Court has completed the scrutiny and confirmed
the legality of the Merger as regards that part of the procedure which concerns the
completion of the Merger, so that Tendercapital and the SICAV may merge upon
