European Communities (Cross Border Merger) Regulations 2008



- That for the purposes of Regulation 14(4) of the Regulations, the merger between IBM Ireland Product Distribution Limited and IBM International Holdings B.V. shall take effect at 6:00 p.m. on the 30th day of November 2010
