## NOTES ON COMPLETION OF FORM LP4

These notes should be read in conjunction with the relevant legislation.

**General** This form must be completed correctly, in full and in accordance with the following notes. Every section of this form must be completed.

Where the space provided on Form LP4 is considered inadequate, the information should be presented on a continuation sheet in the same format as the relevant section in the form. The use of a continuation sheet must be so indicated in the relevant section and noted on the relevant continuation sheet.

**note one** In the case of a new Limited Partner, the Increase or Additional Sum Now Contributed section is not completed. In the case of an existing partner, the section must be completed.

**note two** This statement is to be filed within 7 days of the change taking place.

**note three** This section must be completed by the person who is presenting Form LP4 to the CRO. This may be either the applicant or a person on his/her behalf.

### PLEASE NOTE

The Form LP4 must be accompanied by a completed Form LP2, where the change is in relation to a contribution made by a new/additional limited partner or if an existing limited partner makes an (additional) increase to their capital contribution.
